- **AIDS Outreach Committee:** Coordinates Gift Drive for families affected by HIV/AIDS.
- **Bench Bar Conference Committee:** Plans annual Bench Bar Conference.
- **Campaign for the Homeless Committee:** Oversees annual clothing drive.
- **Communities In Schools Committee:** Supports Communities in Schools Houston's Summer Legal Internship Program.
- **Continuing Legal Education Committee:** Plans continuing legal education programs.
- **County Law Library Committee:** Reviews operation of Harris County Law Library.
- **HBA John J. Eikenburg Law Week Fun Run Committee:** Organizes annual HBA John J. Eikenburg Law Week Fun Run for The Center.
- **Elder Law Committee:** Visits senior citizen sites, supervises publication of Elder Law Handbook, and organizes Will-A-Thon.
- **Fee Dispute Committee:** Arbitrates disputes between attorneys and clients involving legal fees.
- **Gender Fairness Committee:** Addresses issues related to gender equity in legal profession.
- **Golf Tournament Committee:** Plans annual golf tournament.
- **Habitat for Humanity Committee:** Builds homes with Houston Habitat for Humanity.
- **HAY Center Committee:** Works with Houston Alumni and Youth (HAY) Center to serve youth aging out of foster care system.
- **Historical Committee:** Researches and preserves history of association and its members.
- **The Houston Lawyer Editorial Board:** Edits and publishes a bi-monthly magazine.
- **IDEA Committee:** Coordinates Interprofessional Drug Education Alliance (IDEA) between HBA and medical professionals to educate fifth graders.
- **Juvenile Consequences Partnership:** Partnership of the HBA, Harris County Juvenile Probation Department, DA's Office and HPD that provides youth and their parents information about juvenile justice system.
- **Judicial Polls Committee:** Develops, distributes, and disseminates results of judicial preference polls and evaluation questionnaires.
- **Law & the Media Committee:** Plans yearly Law and Media Seminar.
- **Law Week Committee:** Plans comprehensive activities for Law Day, May 1.
- **Lawyers for a Beautiful Houston:** Organizes projects that promote beautification of Houston.
- **Lawyers for Literacy Committee:** Conducts annual book drive and organizes volunteers to read at elementary schools.
- **Membership Committee:** Works to increase membership in the HBA.
- **Minority Opportunities in the Legal Profession Committee:** Organizes summer clerkship program for minority IL students from local law schools.
- **Professionalism Committee:** Promotes professionalism within legal community.
- **Project TRAIN (Training, Readiness And Inclusion Network):** Develops training materials for employers who hire and retain individuals with special needs or other cognitive disorders.
- **Senior Lawyers Forum:** Plans quarterly luncheon meetings and recruits speakers on topics for lawyers 50 and over.
- **Speakers Bureau Committee:** Provides speakers on legal topics for schools, service clubs and other civic organizations.
- **Special Olympics Committee:** Coordinates volunteers for Special Olympics Texas activities.
- **Teach Texas Committee:** Recruits legal professionals to teach court history and judicial civics program to seventh graders.

Ancillary Organizations

The HBA has three ancillary organizations governed by boards of directors rather than committees.

- **Dispute Resolution Center:** Makes recommendations to the HBA on the operation and administration of programs and the yearly budget for the DRC.
- **Houston Lawyer Referral Service:** Makes recommendations to the HBA on the operation and administration of programs and the yearly budget for HLRS.
- **Houston Volunteer Lawyers:** Makes recommendations to the HBA on the operation and administration of programs and the yearly budget for HVL.
