Alternative Dispute Resolution

Scholarships: One \$1,000 scholarship per law school

Meetings: \$10/with reservation, \$15/walk-in

Meetings: Students must pay for cost of lunch if eating (free if not eating)

Scholarships: One \$500 scholarship per law school to the winner of the Best Brief Contest

Meetings: \$45/with reservation, \$50/walk-in

Bankruptcy

Scholarships: One \$1,000 scholarship per law school to a student interested in bankruptcy law

Meetings: No charge to students

Collaborative Law

Scholarships: None

Meetings: \$10/lunch

Commercial & Consumer Law

Scholarships: None

Meetings: \$35/lunch with reservation, \$45/lunch without reservation

Construction Law

Scholarships: No scholarships offered; 2 student sponsorships available to attend the State Bar Construction Law Bar Conference (2 day event)

Meetings: \$15/lunch

Corporate Counsel

Scholarships: One \$1,000 scholarship per law school to a student interested in corporate law

Meetings: No charge for students

Criminal Law & Procedure

Scholarships: None

Meetings: Reservation only

Entertainment & Sports Law

Scholarships: None

Meetings: Students must pay for cost of lunch (\$10-15)

Environmental Law

Scholarships: None

Meetings: \$15/meeting

Family Law

Scholarships: None

Meetings: Students may attend as guest by contacting the Chair, must pay for own meal

Federal Practice

Scholarships: None

Meetings: \$15/meeting; reservations to be made prior to meeting

Health Law

Scholarships: None

Meetings: \$25/meeting

International Law

Scholarships: None

Meetings: No charge to students (up to ten students max)

Juvenile Law

Scholarships: None

Meetings: ½ price rates to students at conferences

Labor & Employment Law

Scholarships: One \$1,000 scholarship per law school to a student who is currently enrolled in an employment law class; student must write an essay and give a 5 minute speech at a section meeting

Meetings: \$10/meeting, must register in advance

Law Practice Management

Scholarships: None

Meetings: Students must pay for cost of lunch

Litigation

Scholarships: Two \$5,000 scholarships per law school to students pursuing a career in litigation. Winners are decided by the law schools.

Meetings: No charge to student, contact chair regarding attendance

Mergers & Acquisitions

Scholarships: None

Meetings: Reservations to be made prior to Meeting, must pay for meal

Oil, Gas & Mineral Law

Scholarships: One \$1,000 scholarship per law school per semester to the student with the highest grade in the oil and gas class

Meetings: \$10/meeting; reservations to be made prior to meeting

Probate, Trusts & Estate

Scholarships: One \$1,000 scholarship per law school; named by the probate class professor to a student who demonstrates excellence in the subject area

Meetings: No charge for students

Real Estate Law

Scholarships: One \$2,000 scholarship per law school to a student interested in real estate law

Meetings: Reservations must be made prior to meeting (up to 5 students per school) with section Treasurer; no lunch fee but must pay for parking

Securities Litigation & Arbitration

Scholarships: None

Meetings: No charge for students

Social Security

Scholarships: none

Meetings: must pay \$30 for lunch, reserve in advance

Taxation

Scholarships: One \$500 scholarship per law school to a student interested in tax law + nominated by professor

Meetings: ½ price
